

Privacy Policy Celery

In this privacy statement, Celery informs you of her policies on how we handle your personal data as controller with the aim of offering the right service.

What is a personal data?

Information about an identified or identifiable natural person is a personal data.

Personal data which Celery processes

We collect several different types of information for various purposes to provide and improve our Service to you.

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

- Email address
- First name and last name
- Phone number
- Cookies and Usage Data

Usage Data may include information such as your computer's IP-address, browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, unique device identifiers and other diagnostic data.

Legal foundations for personal data processing

The processing of personal data takes place on the basis of the "Landsverordening Bescherming Persoonsgegevens" from Curacao. Celery furthermore organizes its business processes, with regard to the processing of personal data, as much as possible according to the principles of the GDPR insofar this does not lead to conflict with the "Landsverordening".

Celery may process your Personal Data because:

- We need to perform a contract with you.
- You have given us permission to do so.
- The processing is in our legitimate interests.
- To comply with the law.

Our legitimate interests include among others: marketing, security, IT management, marketing research into an analysis of products or services, business management, legal affairs and internal management.

Why is personal data processed by Celery?

We process your personal data for the purposes mentioned below:

- To provide and maintain our Service.
- To notify you about changes to our Service.
- To allow you to participate in interactive features of our Service when you choose to do so.
- To provide customer support.
- To gather and analyse data so that we can improve our Service.
- To monitor the usage of our Service.
- To detect, prevent and address technical issues.
- To provide you with news, special offers and general information about other goods, services and events which we offer that are similar to those that you have already purchased or enquired about unless you have opted not to receive such information.

Sharing personal data with third parties

Celery might share your personal data with third parties in the following cases.

- For processing personal data through third parties to whom the processing is outsourced by Celery in the context of its business operations.
- In connection with a legal requirement or an order from the competent authority.
- To comply with legal obligations.
- To protect and defend the rights or property of Celery.
- To prevent or investigate possible wrongdoing in connection with the Service.
- To protect the personal safety of users of the Service or the public.
- To protect against legal liability
- If Celery is involved in a merger, acquisition or asset sale.

Payments providers

We may provide paid products and/or services within the Service. In that case, we use third-party services for payment processing. The payment processor we work with is CX Pay.

We will not store or collect your payment card details. That information is provided directly to our third-party payment processors whose use of your personal information is governed by their Privacy Policy. The payment processor adheres to the standards set by PCI-DSS as managed by the PCI Security Standards Council, which is a joint effort of brands like Visa, Mastercard, American Express and Discover. PCI-DSS requirements help ensure the secure handling of payment information.

Transfer of data outside of Curacao or Europe

Personal data collected by Celery are stored on a server of either Celery itself, a supplier or both. These servers are located on Curacao and in Europe. Celery will take all steps reasonably necessary to ensure that your data is treated securely and in accordance with the "Landsverordening Bescherming Persoonsgegevens" from Curacao.

No transfer of personal data will take place to other countries then Curacao, countries of the "Koninkrijk" and Europe unless there are adequate levels of protection in place.

How long does Celery store your personal data?

Celery retains personal data as long as:

- A customer relationship with Celery is present or you continue to show interest in the products and/or services of Celery.
- Celery is legally required to retain your data.
- Celery on the grounds of necessity may keep your data.

Your rights with regard to personal data

You have the right to know which personal data Celery has recorded and to whom we have provided your personal data. You can contact our administration for this. Celery will respond within the legal periods. In addition to the right of access, you have the following legal rights with respect to our processing of your personal data:

- The right to withdraw your consent, insofar as our processing of your personal data is based on this consent.
- The right to file a complaint with the relevant authorities
- The right to (have) rectified / corrected your personal data.
- The right to delete your personal data.
- The right to limit the processing.
- The absolute right to object to direct marketing.
- The right to object to processing that takes place due to the legitimate interests of Celery.

These rights can only be exercised insofar as the law grants these rights. To ensure that the request was made by yourself, we ask you to send a copy of your ID with this request. In the context of the use of the services of Celery you can receive commercial communication. If you no longer wish to receive it, you can use the unsubscribe option at the bottom of every message you receive.

Cookies and analytics

We use technical and functional cookies in order for our websites and other services to function properly and to analyse the use of those websites and services. Furthermore, we use tracking cookies for commercial purposes.

Security

Celery has taken appropriate technical and organizational security measures to ensure that your personal data are protected against unauthorized processing, loss, destruction and damage.

The way in which personal data is processed and the composition or quantity of data that we process can change. That is why Celery reserves the right to change this privacy statement.
